NEW BUSINESS- Resolution No. 3632-2<sup>nd</sup> Amendment, A Resolution of the City Council to Conditionally Delay the Disposition of All Airport Assets- Alderman Battles said this amendment will give the airport board and public time to respond to the interlocal agreement that the City provided.

Alderman Heaton said they are extending the date to February 15, 2024. She said if the County is not willing to come to the table by then, then the City will need to move on. She said this is a good faith effort. Heaton said the next airport board meeting will be on January 23<sup>rd</sup> at 10:00 a.m.

The disposition of Assets called for in the Interlocal Agreement by August 13, 2023, is hereby stayed until February 15, 2024, December 31, 2023, with the current Airport Board continuing in authority to maintain the Airport in its current state.
