- 16-20 MPH Over Limit \$150.00 Appearance is Required.

- (B) Prevention of Noise, Smoke and Regulation of Muffler Cut-outs
  - \$500.00 Appearance is Required
- 6.1.10(4) Failure to Comply with Notice
  - Bond amount + \$50.00 Admin Fee
- 6.1.11 Refusal to Submit to Breath Test \$500.00 Appearance is Required
- 6.1.13(B) Reckless Driving \$250.00 Appearance is Required

#### 6.1.14(B)(4) - Golf Cart Operation

- (a) Without the use of lights as equipped \$25.00
- (b) Contrary to any traffic law of the City of Red Lodge or the State of Montana - See for violation for recommended bond amount
- (c) With more people than seats within the vehicle \$25.00 Per Person Over
- (d) In any area where motor vehicle traffic is prohibited, blockaded or presents hazardous travel, including, but not limited to, nonmotorized paths or sidewalks - \$250.00 - Appearance is Required.
  - Golf carts are specifically prohibited from operating on public str
- (e) Golf carts are specifically prohibited from operating on public streets for which the posted speed limit exceeds twenty-five (25) miles per hour \$50.00
