1. Answer all questions. Answers should be clear and contain all necessary/relevant information.
2. Your application must include a site plan and elevation plan showing all existing and proposed signs, property lines, setbacks and height of existing and proposed signs.
3. Please include a drawing showing the shape, size, colors and lighting for all proposed signs.
4. Please be sure to sign and date your application.
5. Permit fees are \$10.00 for a Temporary Sign, \$40.00 for a Permanent Sign and \$300 for Neon or Internally Illuminated Signs.
6. Neon and Internally Illuminated Signs are reviewed through the Design Review Process. Neon Signs are held to specific criteria outlined in §4.6.80 RLZR. Other signs are reviewed by the Zoning Administrator.
